Food service members **must meet one of the criteria** below, and are asked to **submit a list of their Savour Ottawa suppliers accompanying this application.**

- Minimum 15%** of annual food purchases are from Savour Ottawa producers/farmers.
OR
 Minimum of \$25,000 of annual food purchases are from Savour Ottawa producers/farmers.

Both categories must purchase from a minimum of 5 Savour Ottawa producers. Consideration can be made for less should your product line be somewhat limited (for example, you sell primarily hamburgers).

* Local food means food produced or raised in Savour Ottawa's "buy local region," from Savour Ottawa verified farmers.

Verification Notes

- All Savour Ottawa members must undergo verification to become members of Savour Ottawa. For food service members this verification involves a review of all Savour Ottawa verified local food* purchases to ensure that the requirement for local food* is being met. The easiest way to do the verification is through a review of vendor accounts or receipts. We do not need to review all your purchases, but rather just Savour Ottawa verified local food* purchases. Timing of the verification depends on the availability of the establishment and the preparation of the vendor accounts.

- I understand that my membership in Savour Ottawa is dependent upon a successful verification of my businesses use of Savour Ottawa verified local food products and that I must meet the criteria listed above.
- I understand that I will be contacted to submit:
- *an updated list of the Savour Ottawa producers that are used in my business, and or/within the product line that I am bringing to sell at the OFM as a food vendor*
 - *receipts from these Savour Ottawa producers to validate the selected membership level*
 - *information confirming the gross retail sales of the business as noted above.*
- I agree to *an on-site visit of the business at the request of Savour Ottawa.*

- I understand and, if required, will follow the Savour Ottawa complaint process when issuing a complaint or when receiving a complaint against myself or my operation. The complaint process is outlined below.
 - *All complaints against another Savour Ottawa member must be issued in writing by the individual making the complaint (email submissions are sufficient).*
 - *The letter will be reviewed and if it is deemed appropriate, a letter from Savour Ottawa will then be issued to the individual against whom the complaint is lodged. The letter will be a reminder of Savour Ottawa regulations and will ask for a written response within 4 days of having received it (an email response is satisfactory).*
 - *The Savour Ottawa Steering Committee will review the written response and make a decision as to next steps and appropriate actions. Appropriate actions may involve sharing some of the information with Farmers' Markets Ontario (FMO), FMO inspectors, Board of Directors (of partner organizations) and / or the Savour Ottawa Advisory Committee. All information will be kept confidential to those required to resolve the issue of a complaint.*
 - *Savour Ottawa reserves the right to alter or change the complaint process. If this is done all Savour Ottawa members will be notified of the changes.*

- I understand that this membership is valid between January 1 and December 31 annually. Any new application received after August 31st will automatically be used for the following year of membership. Membership eligibility, criteria, fees and benefits will be reviewed, and may be modified, annually. All reviews and modifications will be completed only with feedback and consultation with Savour Ottawa members.

- If my Savour Ottawa membership is revoked at any time, or I cease to become a Savour Ottawa member, I will not advertise my business online or otherwise as being connected to Savour Ottawa and I will return all of my Savour Ottawa marketing materials, including my: Savour Ottawa posters, trading cards, stickers and any other materials I have printed with the Savour Ottawa logo.
